## **Definition**

I understand that the activities available at Fern Resort may be considered inherently dangerous and may cause serious or grievous injuries, including bodily injury, damage to personal property and/or death. I understand that certain risks, dangers, and injuries due to inclement weather, slipping, falling, poor skill level, or conditioning, carelessness, horseplay, inadequate or defective equipment, and all other circumstances inherent to outdoor recreational activities/programs exist.

On behalf of myself, my heirs, assigns and next of kin, I waive all claims for damages, injuries and death sustained to me and those I am responsible listed below, my property that I may have against the released party to such activity whether caused by the ordinary negligence of the released party or otherwise, except for acts of gross negligence, or intentional, willful, or wanton misconduct as indicated above.

By this Waiver, I assume any risk for myself and those I am responsible for listed below, and take full responsibility and waive any claims of personal injury, death or damage to personal property associated with using any equipment or facilities and engaging in any outdoor activities owned or operated by the releases.

This WAIVER AND RELEASE contains the entire agreement between the parties and supersedes any prior written or oral agreements between them concerning the subject matter of this WAIVER AND RELEASE. The provisions of this WAIVER AND RELEASE may be waived, altered, amended, or repealed, in whole or in part, only upon the prior written consent of all parties.

The provision of this WAIVER AND RELEASE will continue in full force and effect even after the termination of the activities conducted by, on the premises of, or for the benefit of, the releases, whether by agreement, by operation of law, or otherwise.

I have read, understand, and fully agree to the terms of this WAIVER AND RELEASE. I am the GUARDIANSHIP of the individuals under 18 years of age that are listed on this waiver. I understand and confirm that by signing this WAIVER AND RELEASE I have given up considerable future legal rights. I have signed this Agreement freely, voluntarily, under no duress or threat of duress, without inducement, promise or guarantee being communicated to me. My signature is proof of my intention to execute a complete and unconditional WAIVER AND RELEASE of all liability to the full extent of the law. I am 18 years of age or older and mentally competent to enter this waiver.
